## **2025 Fall Semester Application Guidelines**

#### **NKNU Vietnam Talents Cultivation Program Scholarship**

### **Scholarship and Quota:**

- 1. Several quotas for the current semester (The actual number of awardees will be flexible adjusted based on the sponsors.)
- 2. Award Value:
  - Awardee of Chen-Yung Memorial Foundation, Inc. (awardee must provide a Bank Account Information in Vietnam): an one-time allowance of VND 20,000,000 ;
  - Awardee of Taiwan's Enterprise Sponsor: an one-time allowance of NTD 30,000.
- 3. The scholarship will be cancelled for students who graduate, leave school, or drop out of school.

### Eligibility: An applicant must meet the following requirements:

- 1. Be a Vietnamese citizen.
- 2. Be a degree-seeking student of NKNU with high school graduate or above and has enrolled in accordance with the "Regulations Regarding International Students Undertaking Studies", have excellent academic performance in his/her most recent formal educational study experience, be of good moral character, and have no record of misconduct and not have any criminal records.

#### A person in any of the following categories is ineligible to apply:

- 1. An R.O.C. national or an overseas Chinese student.
- 2. A person who already has and is continuing to maintain student status at another university/college in Taiwan or who has already registered to begin studies at such a university/college. This restriction does not apply to a student who will be graduating after completing a degree that year.
- 3. A person who has already studied in Taiwan for a degree at the same level as the one in which they currently intend to enroll.
- 4. An exchange student or dual/joint degree student.
- 5. A person who is receiving any other scholarship or subsidy from any Taiwan Government institution (organization) or any education institution in Taiwan.
- 6. Students who have a full-time job either on or off-campus, hold an Alien Residence Certificate (ARC) indicating work as the reason for residence, or hold an Alien Permanent Residence Certificate (APRC) are excluded from the application.

#### **Application Procedure:**

**1. Application Period:** Each semester's application is handled separately, and the application should be submitted to the International Affairs Office by the announced deadline.

#### 2. How to apply?

SUBMIT required materials to oia\_students@mail.nknu.edu.tw (which must be done by January 12, 2026)

#### 3. What materials are required?

Please submit the following documents by combining them into a single file in WORD or PDF format, with the file name: application-your name:

- (1) One copy of the completed application form, including autobiography, study plan, certificate of language proficiency for English or Chinese, and other materials such as proof of exceptional performance or service work.
- (2) One photocopy of passport and ARC
- (3) A photocopy of Certificate of Enrollment(COE) of current semester.
- (4) A photocopy of official transcript of the latest semester (if freshman, English or Chinese transcript of full academic records from the previous school authenticated by a Taiwan's overseas representative office, a

- notarized translation is required for any document not in English or Chinese)
- (5) Two letters of recommendation from faculty members of the department to which the student belongs (dated and valid for three months at the time of application; exempted for freshman).

#### 4. Selection Criteria

- (1) Recipients must achieve an undergraduate average academic grade of 70 or above and a graduate average academic grade of 80 or above (on a 100 scale), AND 80 of moral performance or above in the previous academic semester.
- (2) Potential for the development of industry and education in Vietnam, Study Plan, Letters of recommendation, etc.

### 5. What else should applicants do?

Recipients should provide 20 service hours each semester at the Division of International Cooperation, International Affairs Office (DIC, OIA) in order to interact with them and better judge their poise and character, and am required to participate in OIA's official activities.

### **After Applying:**

The reviews can take up to two-three months.

OIA will notify the approved awardees and they must provide a post office or bank account designated by the sponsoring organizations to make the remittance.

### **Scholarship suspension and cancellation:**

- 1. The scholarship shall be suspended during the period students attending an exchange program or conducting researches overseas. The term of the scholarship shall not be extended regardless of the said overseas activities.
- 2. Scholarship recipients shall not be absent from the campus for longer than two months (except during the summer and winter breaks). Suspension that lasts for two consecutive mouths shall result in the cancellation of the scholarship. Absentees with justifiable causes may apply, with supporting documentation, for reinstatement of their scholarship to the QIA.
- 3. Scholarship for recipients applying for suspension of study or deferred enrollment shall be cancelled. After resuming study, students may reapply for the scholarship at a specific time.
- 4. The scholarship shall be cancelled if the recipients violate disciplinary regulations and are issued an official warning or receive a sanction, effectively from the current semester after the disciplinary measure is finalized. Previous monthly scholarship payments shall be returned in fill.
- 5. Scholarship recipients confirmed to work full-time either on or off- campus, hold an Alien Residence Certificate (ARC) indicating work as the reason for residence, or hold an Alien Permanent Residence Certificate (APRC) shall be cancelled. Previous monthly scholarship payments shall be returned in fill.
- 6. Students who are granted various governmental scholarships shall not be eligible for the scholarships stipulated in these regulations. Previous monthly scholarship payments shall be returned in full.

Any dispute over interpretations of these regulations shall be resolved in the court of law based on the Chinese version.
